**ASA CIRCULAR 5 OF 2019
TECHNICAL OFFICIALS MUST BE LICENSED**

Dear ASA Members

With the 2019 athletics season now rapidly building momentum, several million athletes will be participating in more than 1000 competitions over the next few weeks. All the events require Technical Officials that are declared eligible before the individual can officiate.

The only way a Technical Official can be declared eligible is by purchasing an ASA Permanent License. As a point of clarity the function of an accreditation card is to determine the skills level of the Card Holder.

ASA came through a bad spell over the last decade where Technical Officials, due to their ineligibility, resulted in ASA been charged in the High Courts of South Africa, and had to pay more than R10 000 000.00 in damages due to the protocols not been followed by Race Organizers/Technical Delegates/Referees at club or provincial level.

To curb the above challenge ASA significantly tightened the related ASA Rules and Regulations. As a direct result of these rule changes, no unlicensed Technical Official is allowed to serve on any event listed on an ASA National or Provincial athletics event.

Your attention is drawn to the entry form below which allows unlicensed (ineligible) Technical Officials to register to an ASA structure.

ASA Members must take note that should any member allow unlicensed (ineligible) Technical Officials to do duty, any legal action flowing from such action, the provincial/associate member and/or the relevant Race Organizer at fault will be held liable.
