**ASA CIRCULAR 18 OF 2019  
REQUEST RECOMMENDATIONS TO UPDATE 2020 ASA RULES**

Dear ASA Members

The closing date of IAAF Member Countries to make recommendations to update the 2020-2021 IAAF Technical Rules was 3 February 2019.

The mentioned recommendations to amend IAAF Competition Rules will follow a process of scrutiny by IAAF Member Countries and will be submitted at the IAAF Congress in October 2019, for immediate implementation. ASA will be monitoring the IAAF Rule Changes and will align with the amendments if need be.

ASA however also have 2019 Domestic Rules and Regulations, which are tailor-made for the South African environment, but subject to the IAAF Rules. The 2019 Domestic Rules and Regulations are available on the ASA website under "Technical".

In accordance with the ASA Constitution the proposed rule changes must be submitted to the ASA Council for consideration. The ASA Council are due to meet in June 2019.

With the above meeting in mind, ASA kindly request ASA Members to advise ASA which domestic rules and regulations need refinement, updating, or alignment. Please submit a written proposal for proposed refinement, updating, or alignment by stating:

- 1. The number of the rule or regulation**
- 2. The wording of the proposed rule change(s)**

**The recommendations for rule and regulation changes should reach the ASA Office ([ceo@athleticssa.net](mailto:ceo@athleticssa.net)) no later than 28 February 2019.**

A 1<sup>st</sup> draft of recommendations to the 2020 ASA Rules and Regulations will be forwarded to you before the end of March 2019 for further input.

Your assistance regarding the above will be highly appreciated.
