Circular 38 of ASA 2017 (04/10) – 2017 ASA ATHLETE REPRESENTATIVES

Athletes using Athlete Representatives to represent them has been common practice in many countries in the world.

The primary function of the Athlete Representatives where to assist the athlete in negotiating competitions for athletes in their preparation for a major international event e.g. the IAAF World Championships or Olympic Games.

The IAAF received complaints from athletes whom where misrepresented by the Athlete Representatives. In 2012, the IAAF introduced a system whereby Athlete Representatives had to undergo a thorough application procedure before they could represent an athlete from an IAAF Member Country.

ASA whom did not require Athlete Representatives to register in South Africa, also experienced in recent years an increase of complaints from athletes whom where misrepresented by their Athlete Representatives.

In 2016, ASA invited Athletes Representatives to register with ASA and in December 2016 published in the 2017 ASA Domestic Rule book, (Chapter 2 Rule 5) guidelines which Athlete Representatives should adhere too.

Athlete Representatives whom are currently registered to ASA are listed below, and will soon be issued by and ASA Athlete Representative Card to identify themselves when negotiating on behalf of athletes.

Athletes whom are not listed below, and whom are not in possession of an ASA Athlete Representative Card, are not allowed to represent athletes in South Africa.

ASA will conduct a workshop in the 4th quarter of 2017 during which Athlete Representatives not registered yet, can register for the 2018 athletics season. More information in regard will follow soon.
