Circular 90 of ASA 2017 (08/03) – SUCCESSFUL APPLICANTS TO BECOME ASA NATIONAL COACHES

ASA Circulars 66 and 68 has bearing.

ASA provided an amnesty period for Coaches to become ASA National Coaches. The amnesty period closed at 31 July 2017.

Please find attached the successful applicants whom adhere to the minimum requirements to apply for amnesty.

With regards to the applicants' number 2 and 19 on the list below, both from EPA, the applicants have not provided their ASA License Numbers.

ASA contacted the individuals numerous times without success. ASA also left messages for them to contact ASA urgently. This also failed. The applications of the mentioned coaches (number 2 and 19) are therefore accepted conditionally. If ASA do not receive proof of them been licensed to the relevant Province by 11 August 2017 their applications will be withdrawn.

ASA Provinces are kindly requested to confirm if the listed Coaches are in good standing with the relevant ASA Province. A response is required from the ASA Provinces by 11 August 2017, latest.

With regards to the listed applications for amnesty; as soon as the relevant ASA Province confirms that the Coaches are in good standing with the ASA Province, ASA National Coaches Committee will proceed in preparing the amnesty coaches for the ASA National Coaches Symposium scheduled for 7 – 8 October 2017.
