The appeal should contain the performance of the athlete, and the date/event of the achievement or the reason for not participating at the ASA Youth and Junior Champions where applicable.

Athletes without a 2018 ASA Permanent License cannot appeal.

NB: ASA selected 3 relay teams. As the IAAF only allows two athletes per event to be entered; in some cases athletes are selected for the relays only.

A final team to the 2018 IAAF World Junior Championships will be announced no later than 31 May 2018.
