**CIRCULAR 72 OF ASA 2019 (07/27)
UPDATE ON ORDERING 2020 PROVINCIAL LICENSE BIB**

Dear ASA Members

ASA Circular 68 has bearing. In ASA Circular 68 ASA Members were required to submit to ASA the amount of License Bibs required for 2020.

It came to the attention of the ASA Office that there is some confusion in licenses for foreign athletes participating in South Africa. The rules related to this issuing process was adopted at the 2019 ASA AGM.

In view of the uncertainty around the issuing of License Bibs for foreign athletes, Members are asked not to order License Bibs for foreign athletes at this point in time. The issuing of License Bibs for foreign athletes will be discussed at the ASA Council Meeting, to allow the ASA Council to give direction in this regard.

Lastly, with regards to the ordering of permanent licenses and temporary licenses, please continue submitting the quantities needed by the Members, as ASA need the quantities to process the orders as soon as possible.

If all go well, ASA will be delivering the 2020 License Bibs no later than in the first week in November 2019 to allow provinces to issue the 2020 license bibs before the end of the year, effective 1 January 2020.
