Provinces can now order the above-mentioned publications from ASA.

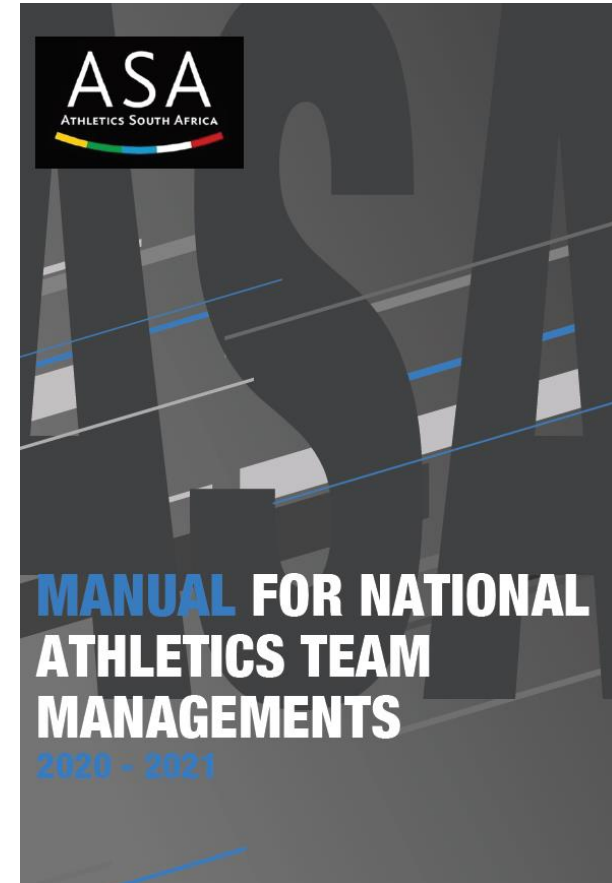
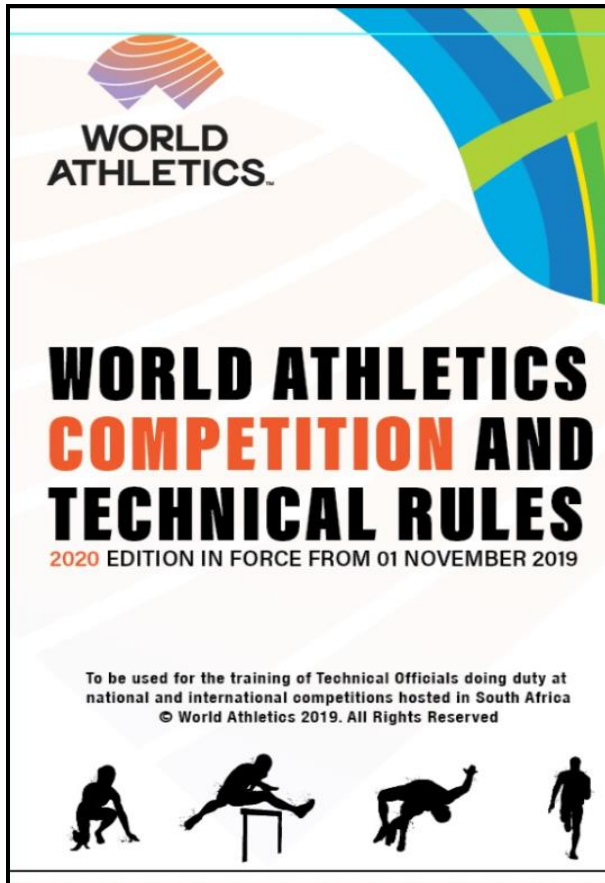
